R and G Chair and committee met to discuss and take actions. The committee decided to suspend the player for a term of 5 years with an official start date as of close of the board meeting currently in progress (02 September 2024). He will not be permitted at any SADA sanctioned functions for that duration. It was asked if the board would like to add anything in addition to the recommended actions to be taken as suggested by the R & G committee. A motion was made to add to that recommended action that if the player returns to SADA after the 5-year suspension a zero-tolerance action will be enforced. If any violations should occur, at any time after the player returns, he will again be suspended from all SADA sanctioned functions permanently. Motion was seconded. Motion Passed.

Corin Noonan will contact the player and notify him of the actions taken by the R & G committee and further actions passed by the SADA board.
